Instructions for registration

ATTENTION: follow by book.

Procedure:

- a. Registrations must be sent by email only. **Photographed forms will not be accepted; only scanned forms in PDF format will be accepted.**
- b. Within two days of receiving registrations, an email will be sent containing the fee to be paid by bank transfer. Cancellations must be received by the registration deadline. After this date, the registration fee will still be due and will not be refunded.

- c. Registrations will be accepted after receiving a copy of the bank transfer via email, which must be made no later than the catalog closing date (**March 29, 2026**). A copy of the bank transfer must be sent to the same email address where the registrations were sent.
- d. A veterinary examination is mandatory upon entry to the expo
- e. Microchips are mandatory for registered cats..

On the F.I.A.F. website homepage, you will find links to download the registration form in PDF and editable PDF formats.

NOTICES/REMARKS

- Photocopied forms will not be accepted.
- Only cats born and bred in Italy with a pedigree issued by an association recognised by MASAF will be accepted.
- Entries for cats born and bred in Italy that don't have a FIAF pedigree must be accompanied by a copy of the pedigree. Incomplete entries will not be accepted.
- Kittens belonging to Italian owners with a non-FIAF LO in progress must be accompanied by a copy of the birth certificate and the relevant payment together with the registration form.
- Each exhibitor may be accompanied by only one other person and any minor children.
- Registration for the WCF Ring will only be accepted if indicated on the registration form.
- Cats registered in the P.H. and P.H.N. classes must send the certificate received from WCF together with the registration form.
- Cats registered for the master ring, double master ring, triple master ring must send the document proving their eligibility to participate in the rings together with the registration form.
- Registrations will be accepted until all cages and spaces are filled.
- For each cat registered after the registration deadline, a penalty of €10.00 will be charged if accepted.
- By registering, the exhibitor acknowledges the authority of the FIAF and its regulations.
- Individual exhibitors are responsible for the care of their cats.
- Participation is at your own risk.
- Cats are strictly prohibited from leaving their cages during public viewing hours and must remain in their cages for the entire duration of the exhibition, under penalty of sanctions and suspension of titles.

VETERINARY REQUIREMENTS

- All cats must be immunised with a trivalent vaccine. The trivalent vaccination and booster for kittens must have been administered at least 15 days prior the show.
- Cats coming from foreign Countries must have a passport and have received two trivalent vaccinations and a rabies vaccination.

PERSONAL CAGES

- Cages measuring a maximum of 130 cm in length must accommodate two adult cats or three kittens.
- Cages measuring 130 cm will be charged at the double cage rate if they accommodate a single cat.
- Personal cages measuring 70 cm in length must accommodate only one cat, but will be charged as a double cage. Any excess space on the table must be left free and not occupied with personal items.
- Cages measuring more than 130 cm in length will still pay the supplement for 2 double cages if they accommodate two cats, and will pay the supplement for one double cage if they contain three cats.
